Sage ERP Accpac Version 6.0

The Sage ERP Accpac Version 6.0 release marked a significant update to the underlying technology. An update that paves the way for an ERP application that is transforming itself from a traditional Windows-based product to a modern web-based application. These technological changes make it easier to access your Sage ERP Accpac system using a web browser or mobile device as well as more straight-forward integration with other web-based software and services you might be using currently.

Version 6 also incorporates several of the most highly-requested features [based on feedback](#) from customers like you including the ability to lock fiscal periods by module, more insightful analytics with the new **Accpac Inquiry**, built-in business intelligence tools like **Sage Accpac Intelligence**, more efficient workflow processes throughout the application, and tighter integration with SageCRM.

6 TIPS FOR A SUCCESSFUL YEAR END

General Closing Procedures and Important Deadlines

1. **Create a New Fiscal Calendar** - Accpac allows you to begin entering transactions for the new year without closing out the current year. But you must first create a new fiscal calendar in **Common Services** before entering transactions for 2012.
2. **General Ledger Closing** - While it's a good idea to close modules and purge historical data in a timely fashion, your General Ledger can remain open as long as you need while awaiting final processing in other modules or audit adjustments.
3. **Check Your Version Number** - closing procedures can vary depending on the version of Accpac you're currently running. So be sure to check your version number and service pack before starting year end.
4. **Back Up Your Data** - before you begin any year end process, be sure to execute a complete back up of your database. You should also **test the back up** to ensure it was successful and the data is readable. The only way to "reverse" year end processing is to restore your data from a back up. So do it now!
5. **Check Data Retention Settings** - Accpac retains historical data based on the version you're running and the settings you've configured in each module. So it's a good idea to double check your settings so you don't lose important data during year end close.

IMPORTANT DEADLINES & TAX INFORMATION



January 31, 2012 - Deadline to issue W-2, 1098, and 1099 forms to employees & independent contractors.

January 31, 2012 - Deadline for filing quarterly payroll & annual sales tax returns.

Depreciation and Section 179 Expense - Last year's Small Business Jobs Act (SBJA) of 2010 **increased** the Section 179 deduction to **\$500,000**. The phase out threshold for qualifying Sec. 179 expenses increased to **\$2 Million**, up from \$800,000 previously.

Standard Mileage Rate - Beginning on January 1, 2011 through June 30, 2011, the standard mileage rate for operating an automobile for business use is **51 cents per mile**. From July 1, 2011 through December 31, 2011, the standard mileage rate increases to **55.5 cents per mile**.

HIRE Act Worker Retention Credit - if your business hired a previously unemployed worker last year, 2011 is the year you qualify for up to a \$1,000 tax credit for keeping that person employed.

Informational Reporting of Employer-Sponsored Health Coverage - Reporting employee's annual cost of health insurance coverage on form W-2 is **NOT mandatory** until 2012. However, the ability to **voluntarily** report such information in 2011 using code DD in W-2 Box 12 will be included in the year end PUP.

2011 YEAR END FAQ'S

For Payroll and Electronic Reporting

To help you get a jump start on closing the year out smoothly, here are some of the most Frequently Asked Questions and answers related to Payroll Processing and Electronic Reporting.

When will the year end Payroll Tax Update (PUP) be available?

The January 1, 2012 Payroll Tax Update (PUP) is expected to be available December 20, 2011 and can be downloaded from the [Sage Customer Portal](#). A user name and password is required in order to download the update.

What's included in the download?

It ensures that you have the most up-to-date tax rates for the new year. The download also provides an enhancement to support new rules in states that require multiple local tax rates to be assessed for employees.

Sage will update the PUP with any late-breaking legislative and tax rate changes, as necessary, throughout January 2012. Therefore, a second update will be provided on January 31, 2012 so be sure to check back if you download your first update prior to the end of January.

What's New in the Year End Payroll Update?

In accordance with the Social Security Administration's 2011 specifications for electronic W-2 filing (EFW2), Codes DD (Cost of employer-sponsored health coverage - not mandatory for 2011) and EE (Designated Roth contributions under a Section 475(b) plan) for Box 12 have been added.

A new field has also been added to identify the Type of Employer as required by the SSA.

Lastly, U.S. Federal withholding changes have been increased to accommodate changes to the Social Security wage base for 2012 to \$110,000.

How do I get a logon to access the Sage Customer Portal?

If you don't have a current logon to the Sage Customer Portal, go to <https://customers.sagenorthamerica.com>, click the "Logon (Sign Up)" link, and follow the on-screen instructions. If you're having trouble or need assistance, please contact (877) 828-6372.

Note: You must have an active [Sage Business Care](#) plan along with a current membership agreement in order to access the Sage Customer Portal. You must also have a current PUP subscription in effect in order to download the update.

The Road Ahead for Sage ERP Accpac

Looking ahead to 2012 and beyond, here are some of the developments and planned new releases to watch for related to your Sage ERP Accpac system.

Sage ERP Accpac Version 6.1

Sage ERP Accpac Version 6.1 is the next step in the product's journey to become a fully web-based application ... a journey that started in Version 6.0 with the introduction of web-based Desktop Portals, Dashboards, and Inquiry Tool.

With Version 6.1, many of the "core" modules will be available as web versions including General Ledger, Accounts Payable and Receivable, Inventory Control, Purchase Order, and Sales Order.

But more than just cosmetically moving thousands of traditional Windows-based screens to the web, Sage intends on making improvements and productivity enhancements along the way. Things like logical grouping of tabs instead of floating pop-up windows, expandable panels, screens that are customizable for each user, workflow enhancements, onscreen interactive video tutorials, and more.

Originally scheduled for release sometime during the 4th quarter of 2011, it was recently announced that Version 6.1 is being pushed back until sometime in mid 2012. Sage has acknowledged that completion of the web platform is taking a bit longer than originally expected. So keep your eyes out for Version 6.1 sometime in the middle of next year. We'll keep you posted.

Sage ERP Accpac Version 6.2

With Version 6.2, the entire Accpac system will be available as a web-based application. This release will also feature approval workflows, a Payroll web client, and new customization tools to personalize your Accpac system. Version 6.2 is scheduled for release in late 2012. However with the delay of



Version 6.1, it's likely that Version 6.2 will be pushed back accordingly. Again, we'll keep you posted and provide more detail as it becomes available.
